To all Teamster members who reside in the State of Indiana:

We are in the process of applying for specialty Teamster vanity license plates. We are asking all Indiana Teamster Members, their families and their Local Unions to participate in the application process by signing the enclosed petition. The State of Indiana requires a minimum of 500 signatures on the petition to be eligible to apply for a Specialty Teamster License Plate. Once the application is approved, we will have a period of three (3) years to meet the minimum requirement of 500 Teamster Specialty being purchased and thereafter the 500 minimum requirement must be maintained every year.

As some of you may recall, we previously were approved, sadly however, in the final third (3rd) year we fell short of the 500 minimum purchase requirement by less than twenty (20). So, we lost the State's approval and now we must start all over again beginning with the application process. Please solicit as many signatures from Teamster members and their families and return your petitions to your Local Union and/or directly to Teamsters Local 142 at 1300 Clark Road, Gary, IN 46404, no later than March 1, 2019.

The organization must also complete an application (State Form 54852) which is subject to review under IC 9-18-25. This petition must be filed with the Bureau of Motor Vehicles by the applicant on or before 3 pm ET April 1. Application is for plate issuance the following registration year. This petition must contain the original signatures of at least five hundred (500) residents of indiana who pledge to prechase the special group recognition license plate in accordance with IC 9-18-25-2.3(a)(8), to meet an application for participation requirement (attach and number additional pages, as needed). The petition must be submitted with the application (State Form 54852). The BMV reserves the discretion to deny an application if the pledge list is incomplete or appears fraudulent.
